



**CODE OF CONDUCT**

The Glacier Institute expects our participants to conduct themselves in a responsible manner. The following addresses particular behaviors expected during your stay.

- Fireworks, firearms, illegal drugs, tobacco and alcohol are not permitted during your stay with The Glacier Institute. Participants possessing any of these will be sent home.
- Bunkhouses are off limits to individuals of the opposite sex. There will be a men's and women's bunkhouse. The nightly curfew for all participants to be in their bunkhouses is 10 p.m. or another time determined by the director, teacher or course instructor.
- All food must be stored in the kitchen to prevent any problems with small mammals in the bunkhouses.
- You are responsible for cleaning and upkeep of the premises. You will also be assigned to a duty group to help with cleaning of the kitchen after meals and the bunkhouses at the end of the program.

The Big Creek Outdoor Education Center is located in a very special area. To keep the area special, we ask that you respect the facility, natural surroundings, and other folks at camp. This includes helping us to recycle, pick up litter, and keeping the place looking good!

The facility has been nominated for the National Historic Register; we must take good care of it. The electricity for the facility is provided by a generator. The power is turned on and off daily as needed. To prevent overloading the generator we cannot have lots of electrical appliances in use at Big Creek.

Please be aware that Glacier Institute staff may be on hand to take photographs of classes and courses. All Photos taken by glacier Institute staff are the property of the Glacier Institute and may be used in publications or web content.
